Executive Board Meeting

MINUTES

Friday, February 6, 2026, via Zoom

Call to Order - President Adam Webb called the meeting to order at 9:01 AM.

Roll Call & Minutes - A quorum was established, and attendance was recorded. The consent agenda and reports were distributed before the meeting. Lacy Wolf moved to approve the agenda; the motion was seconded and carried. Lacy Wolf moved to approve the December 12, 2025, minutes, and LaShonda Campbell seconded. The motion carried.

Consent Agenda - Lacy Wolf moved to approve the consent agenda, and Cassandra Barnett seconded. The motion carried.

Financial Report - Treasurer Clare Graham was not present, but the Financial Report was distributed and reviewed. Current balances: \$117,580.97 in Arvest, and \$106,706.35 in Edward Jones, and \$20,225.80 on a CD at Edward Jones. LaShonda Campbell moved to approve the Financial Report, and Lacy Wolf seconded. The motion carried.

President's Report - President Adam Webb shared a last-minute update regarding the Arkansas Library Association's role as a co-sponsor for a screening of *The Librarians* at the Central Arkansas Library System on February 10th. Additional partners include Arkansas Right to Read and decARcerate. It was also announced that the film will be presented at the North Little Rock Library System in April and will feature a panel discussion featuring representatives from various fields of librarianship.

President Webb further reported that he will attend Legislative Day in Washington, D.C. on February 25th and 26th as part of the American Library Association's federal delegation. The visit will emphasize advocacy efforts related to federal capital improvement projects and continued support for libraries at the national level.
